

Town of Elmer City Ordinance No. 367

*An Ordinance of the Town of Elmer City, Washington,
Adopting the 2023 Budget, for the Fiscal Year Ending December 31, 2023.*

WHEREAS, the Town of Elmer City completed a proposed budget and estimate of the amount of monies required to meet expenses of government for the Town of Elmer City for the fiscal year ending December 31, 2023; and

WHEREAS, a notice was published that the City Council would meet on December 1, 2022 at 5 p.m. at city hall for the purpose of making and adopting a budget for said fiscal year and giving taxpayers within the city limits an opportunity to be heard in a public hearing upon said budget; and

WHEREAS, City Council did hold a public hearing at the said time and place and did then consider the matter of the proposed budget for the fiscal year 2023; and

WHEREAS, the proposed budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the City for the purposed set forth in the budget, and the estimated expenditures set forth in the budget being all necessary to carry on the government of the City for the fiscal year of 2023 and being sufficient to meet the various needs of the City during that period; and

NOW THEREFORE, the City Council for the Town of Elmer City, do ordain as follows:

SECTION 1: The budget for the Town of Elmer City, Washington for the year of 2023 is hereby adopted at the fund level in its final form and content as set forth in the comprehensive budget document, "The Town of Elmer City – Final Budget – Fiscal Year 2023," copies of which are on file in the office of the City Clerk.

SECTION 2: Estimated resources for each separate fund of the Town of Elmer City, and aggregated expenditures for all such funds for the year 2023 are set forth in the summary form below, and are hereby appropriated for the expenditures at the fund level during the year 2023 as set forth in The Town of Elmer City – Final Budget – Fiscal Year 2023,"
